#### MARGAUX MEIDINGER

Head of European CSR Affairs, La Poste France

Having worked for the La Poste Group more than 13 years, Ms Meidinger has held different positions across the company related to human resources, European affairs and sustainability. In her current position as Head of European CSR Affairs, she follows EU regulation related to the Green Deal and social issues while serving as La Poste's representative on sustainability issues in all sectoral international bodies.
