# Principal benefits of .POST for your postal activities

- 1 Security and trust
- 2 Visibility and brand image

The UPU ensures that every **owner of .POST domains is verified and adheres to the rigorous security standards required for all .POST domains**.

.POST is 100% secured by Domain Name System Security Extensions (DNSSEC), and is the most secure sTLD for postal services on the internet.

#### **INNOVATION & GROWTH:**

.POST is designed to be a space for INNOVATION where the **global postal stakeholder community** can interconnect their domains and services in a safe and trusted environment, opening up the possibility for digital postal services and business models.





#### .POST PROTECTS YOU IN 5 WAYS

- 1) Protection against Denial of Service attacks (DDOS protection)
- 2) Protection against your domain being hijacked and spoofed (DNSSEC)
- 3) Protection against malicious emails from your domains (SPF and DKIM)
- 4) Encryption required for all .POST websites (HTTPS & TLS)
- 5) Verified domain (VERIFIED BY UPU)

# Increase visibility with .POST websites and email addresses



Registering your key brands and websites under .POST will give you **VISIBILITY:** 

- .POST domains provide a clear and unmistakable brand for the global postal stakeholder community as a trusted and reliable source of postal services online.
- A .POST domain raises the profile of your organization, extends it beyond national frontiers, and provides greater opportunities for growth.





#### **.POST Policies**

#### **Updated RoP and DMP**

The updated .POST Rules of Procedure and Domain Management Policiy allow members to:

- ☐ Use **premium domain names** containing country names and alpha-2 country codes specified in the ISO 3166-1 list
- ☐ Use membership fees by DPG full members to **offset** domain name registration fees
- □ Register domain names that integrate the .POST TLD, where such name replicates in its entirety or to a substantial degree the trademark, trade name or service mark supporting the requested domain name (i.e. "spanning the dot")





#### **Advantages of .POST policies**

All .POST domains with MX record should comply with the e-mail policy and use DKIM and SPF records <a href="https://tools.ietf.org/html/rfc5376">https://tools.ietf.org/html/rfc5376</a> <a href="https://tools.ietf.org/html/rfc5585">https://tools.ietf.org/html/rfc5585</a>	Improve the trust on e-mail under .POST






# How to register your .POST domain names

## **Register your Domain Name**



- **1. Validate your organisation**: apply for your Community ID <a href="https://register.post/registrant-corner/community-id">https://register.post/registrant-corner/community-id</a>
- 2. Request your Domain name: submit the name request <a href="https://register.post/get-post">https://register.post/get-post</a>
- **3. Receive approval from the UPU** after compliance validation and public comment period.





#### **Annual Fees (CHF)**

Туре	Full member (all prices in CHF)
DPG membership fee	Lvl 1-5: 5,000 - 100,000 Lvl L (LDCs): 2,500
Standard name	100 (offset against DPG membership fee)
ISO country code/name	2,500 (offset against DPG membership fee)
Security Monitoring	O (Included in DPG fee)

#### **DPG** membership fee offset principle:

DPG Full Members can register a combination of premium and standard names up to the value of their membership fee.

e.g. DPG Level 2 = 1 premium country name and up to 75 standard names OR 2 premium country names + 50 standard names.




#### 1. CONTEXT

- "South-South cooperation for Africa" initiative from the CEO Forum;
- Official launch of Africa Philately Shop on the sidelines of the 26th UPU Congress in Istanbul in October 2016;
- Commemoration of the launch with the collective issue of an "Africa Philately Shop" postage stamp during the official inauguration of the Africa Philately Portal.
  - Countries that contributed to the launch issue: Burkina Faso, Mauritania, Morocco and Senegal.
- Current members of the philately shop:
  - ➤ 14 countries already have products available on the Africa Philately Shop: Benin, Burkina Faso, Burundi, Central African Rep., Congo (Rep.), Côte d'Ivoire (Rep.), Guinea, Mali, Mauritania, Morocco, Niger, Nigeria, Senegal and Togo.
  - Six countries in the process of joining: Cameroon, Dem. Rep. of the Congo, Egypt, State of Libya and Tunisia

# Why did we register a .POST domain name?

La Poste de Côte d'Ivoire registered a .POST domain name to enable any person connecting to its platforms to see that they are dealing with a postal administration, increasing their confidence in the transactions they carry out there.





## Benefits of a .POST domain name

#### - Branding benefits

#### Registration process overview

Registering your .POST domains is a 3-step process:

- 1. Application: apply for your Community ID at https://apply.info.post
- 2. Authentication: verification process and issuing of your Community ID
- 3. Registration: register your domain name providing all the requested information
