Subject: Invitation to the Council of Administration (CA) and Postal Operations Council (POC) sessions (19–30 April 2021)

Dear Sir/Madam,

On behalf of the Chairman of the Council of Administration and the Chairman of the Postal Operations Council, I wish to invite the members of the CA and the POC and observers to attend the regular 2021.1 CA and 2021.1 POC sessions (S9). The meetings are to be held at the UPU International Bureau (IB) in Berne from 19 to 23 April 2021 (POC) and from 26 to 30 April 2021 (CA), each day from 12.00 to 16.00 CEST (UTC+2). In the week before the POC session (12 to 16 April 2021), there will be meetings of POC user-funded groups and the Quality of Service Fund Board. The timetable and the provisional agendas and meeting documents for the CA and POC will be available on the UPU website at www.upu.int/en/Members-Centre.

It should be noted that, following the consultations undertaken through IB circular letters, the CA and POC decided to allow for remote participation by those members and observers unable to attend the sessions in person because of the COVID-19 pandemic; accordingly, as set out in Annexes 1 and 2, a number of provisions of the CA and POC Rules of Procedure have been amended and/or suspended to allow for remote participation.

i Remote participation

As a result of the ongoing COVID-19 pandemic, the Government of Switzerland has prohibited the holding of all public events as of 12 December 2020 until further notice. Meetings of international organizations with participants from member countries or external delegates are considered public events. Nonetheless, in order to comply with the requirements of the UPU General Regulations that sessions of the CA and POC be held physically at least in part, an exception is being sought from the Swiss Government for the physical attendance of a very limited number of participants from the delegations of the CA and POC Chairs (Turkey and Japan, respectively). Accordingly, representatives of all other CA and POC members and observers may only participate remotely.

ii Registration of participants and remote participation tool

All delegates from CA and POC members and observers attending the session remotely are required to register. A new platform for remote participation is being developed with new registration procedures. Technical details relating to remote participation and instructions for registration will be forwarded shortly in a separate circular letter.

iii Submission by UPU member countries of questions to be discussed at CA and POC sessions

Pursuant to article 14.3.2 of the CA Rules of Procedure and article 15.3.2 of the POC Rules of Procedure, any UPU member country wishing to submit questions for discussion at this joint CA/POC session is required to send the relevant documents to the Secretary General at least six weeks before the opening of the session (8 March 2021 for POC and 15 March 2021 for CA).

Suspension and/or amendment of certain provisions of the Rules of Procedure of the Council of Administration in order to allow for remote representation of CA members and observers
